# Introduction

centrexIT struggled with managing compliance services using online policy templates. Besides being inefficient and unscalable, this approach failed to support their own cybersecurity maturity roadmap.

## The Challenge: Policy documentation & management

Built on the Center for Internet Security (CIS) controls, centrexIT's cybersecurity maturity roadmap is a structured framework that outlines the company's cybersecurity objectives and provides proactive processes for evaluating and managing risk. The roadmap is also a centerpiece of the organization that all clients must align with. In practice, it means centrixIT asks clients to implement certain policies before they can be checked off on the roadmap.

Before adopting Compliance Scorecard, centrexIT had no way of providing the correct documentation when clients did not have those policies in place. In these instances, they either located a suitable template online, or they referred the client to a third party, which sometimes charged thousands of dollars to create one policy document. Regardless of what they chose, the shortcomings of each approach became increasingly more apparent as centrexIT grew.

- Restricted growth: The inefficiency made the processes impossible to scale.
- Security concerns: Lack of control, storage, and ability to manage the documents raised questions about security.
- Loss of revenue: The inability to provide an in-house policy documentation and management service risked limiting revenue growth.

Hobhein explains, "We literally would just have been hands-off... and we would be missing out on revenue. Or we would refer them to a third party, and they charge \$10,000 to create one policy document. And again, we're missing out on the revenue and someone else gets to charge a lot."
